Staff Reports:

City Manager Latham reported that all city buildings were officially open today, including the library. He recognized the efforts of Chief Conrad and Director Dave Slover who toured each facility and assessed the safety needs. People will need to wear a mask. Protection has been provided around areas where bills are paid. Director Rosen and the Parks & Recreation Staff have done everything this past month to figure out how to reopen the Korte Rec Center. Phase III will allow for its reopening on June 8. Director Rosen explained this is a way to allow us to ramp up to the next phase, under state guidelines. Basically, it is one trainer per person, utilizing our fulltime staff. We will test the waters and see how it goes. City Manager Latham reported they are also sending information up to the state to try to get the pool open for those with therapeutic needs. Mayor Michaelis asked is the walking track open. Director Rosen reported it is for members only. They will need to call to make a one-hour appointment per person. We are open 6am-9am, close for one hour to sanitize, then open 10am-1pm; and, reopen again 3pm-6pm. Councilwoman Bellm asked how many can you let in at a time. Director Rosen replied six total. Members can make reservations to walk, use machines or the weights. We are utilizing full-time staff to work with the members.

City Manager Latham reported the Broadway Reconstruction is at ninety-eight percent complete. We are waiting on the striping and markings.
