asked City Manager Conrad to explain this. City Manager Conrad reported this to take a big swing with the problems we have with ground washing into the lake. This property will be part of a catch basin that one of the landowners will be constructing. All of the property must be under one ownership for the 319 Grant. This is a very big swing at the problem. We are very grateful for Mr. Urban for working on this. Mayor Hemann inquired by declaring it surplus others could come in to purchase it. City Manager Conrad noted this property is very specific in location. There will be ingress and egress easements for maintenance. Additionally, it could revert to the city under certain conditions of the sales agreement. Roll Call Vote: Councilmembers Klaus, Sloan, Bellm, and Napper voted aye, none nay. Motion carried.
