# MINUTES OF REGULAR SESSION HIGHLAND CITY COUNCIL MONDAY, OCTOBER 20, 2025

Mayor Kevin Hemann called the Regular Session to order at 6:30pm. Council members Klaus, Sloan, Bellm and Napper were present. Others in attendance were City Manager Conrad, City Attorney Kathryn Warren, Directors Gillespie, Heimburger, Hubbard, Koehnemann, Wilken and Widman, City Treasurer Nicolaides, Deputy Clerk Flake and 4 citizens.

## **MINUTES**

Councilwoman Bellm made a motion to approve the minutes of the October 6, 2025 Regular Session as attached; seconded by Councilman Napper. Roll Call Vote: Councilmembers Klaus, Sloan, Bellm, and Napper voted aye, none nay. Motion carried.

Councilwoman Sloan made a motion to approve the minutes of the October 6, 2025 Executive Session as attached; seconded by Councilman Klaus. Roll Call Vote: Councilmembers Klaus, Sloan, Bellm, and Napper voted aye, none nay. Motion carried.

Mayor Hemann opened a sealed bid for the Silver Lake North Dam Property. Hemann advised that we received one bid. City Manager Conrad stated that we will not take any action tonight. He advised that we will evaluate the bid and make a recommendation at the next meeting. Mayor Hemann advised that the bid is from Charles and Susan Urban. The bid states, "I propose to purchase the roughly 1.836 advertised as part of PIN# 02-1-18-00-000-025 as part of a larger drainage basin project with the IL EPA grant program referred to as 319 grants. If awarded the property, as consideration I propose constructing a dam on the portion of ground described above which will then create a catch basin for sediment and runoff from almost 200 acres of ground that would otherwise drain into Silver Lake. The majority of the pond would be on existing property I already own, or am working in conjunction with other landowners. As the owner, the maintenance and upkeep of the pond and dam will be the responsibility of me and any successive owners. As further consideration, I agree to a reversion on the property so that if the ground subject to this bid is no longer used for the purpose of the dam and catch basin, that the ground would return to the City."

### **PUBLIC FORUM**

## Citizens' Requests and Comments:

<u>Annual Lighted Christmas Parade – Special Event Application</u> – Taylor Sheely requested an amendment to the Annual Lighted Christmas Parade special event application. They are wanting to broadcast the parade for people who cannot attend. Councilwoman Bellm made a motion to approve the amendment to the special event application as attached. Seconded by Councilman Napper. Roll Call Vote: Councilmembers Klaus, Sloan, Bellm, and Napper voted aye, none nay. Motion carried.

<u>First Congregational Church Fall Festival – Special Event Application</u> – Mayor Hemann advised that this event occurred yesterday, so there will be no vote on the special event application.

## Requests of Council:

Councilwoman Sloan wants to readdress the trash issue. Sloan stated that she has seen furniture piled up on the streets and trash cans full. She would like to readdress this, due to the weather changing. City Manager Conrad stated that we can push out information through our social media channels.

## Staff Reports:

Conrad informed the council that we are pleased to report that we received a letter from IDOT. This funding letter is a state appropriation and separate from the grant program that we applied for. This is for the Poplar Street South reconstruction project. This will be from VFW Road to 30<sup>th</sup> Street. This will allow us to put in gutters, curbing, a center turn lane, and also a shared use path from VFW Road to the new school. We have scheduled a meeting with the Department of Transportation Local Roads at the end of this month to put together a timeline to complete the project. This is for the full amount of 2.6 million dollars. Mayor Hemann stated that we would like to thank our Representatives and our Senator. Conrad stated that we are extremely grateful to Representatives Hoffmann and Meier who worked on this. We are also thankful to Senator Plummer who was a supporter of this and Secretary of Transportation Biagi. This will be a nice addition to the community.

#### **NEW BUSINESS**

Approve Mayor's Reappointments of Jacob Rose and Jeffrey Menz to the Historical Commission—Councilwoman Bellm made a motion to approve Mayor's reappointments of Jacob Rose and Jeffrey Menz to the Historical Commission for a three-year term expiring in October of 2028. Seconded by Councilwoman Sloan. Roll Call Vote: Councilmembers Klaus, Sloan, Bellm, and Napper voted aye, none nay. Motion carried.

Award Bid # E-14-25, for Purchase of 7 – 75 kVA Padmount Distribution Transformers – Councilwoman Sloan made a motion to award bid # E-14-15, for purchase of 7 – 75 kVA Padmount Distribution Transformer, in the amount of \$28,525.00 as attached. Seconded by Councilman Napper. City Manager Conrad stated that we are now receiving transformers in weeks, rather than years. Mayor Hemann stated that this is great news. Roll Call Vote: Councilmembers Klaus, Sloan, Bellm, and Napper voted aye, none nay. Motion carried.
